

Buchanan Community Schools Student 1:1 Device Program Acceptable Use Policy Agreement

Definitions: AGREEMENT: This document, its attachments, addendums and appendices. STUDENT: Student enrolled in Buchanan Community Schools for which this AGREEMENT applies. DEVICE(S): The Internet enabled device assigned to the student and belonging to the school. GUARDIAN: Legal guardian and responsible party for STUDENT.

Purpose: This AGREEMENT is to provide understanding and define expectations for the use and care of the DEVICE and the responsibilities of the STUDENT and GUARDIAN for the DEVICE.

General Conditions: To participate in this program the undersigned must:

- Agree to use the DEVICE to support and enhance student learning through such things as academic research, document preparation, complete classroom-based and homework assignments, access the Internet for school related information, anytime, anywhere learning activities, and to communicate with peers, parents and teachers
- Agree that participation in this program may be revoked or suspended by the school for any reason
- Agree to use the DEVICE in compliance with the district's acceptable use policy(s) with the understanding that all activity can and will be monitored
- Agree to use only licensed software on the DEVICE
- Agree to properly use, store and transport the DEVICE
- Agree not to intentionally damage or demonstrate careless use of the DEVICE
- Agree not to visit Internet sites that contain illegal, obscene, or hateful content, or view, download or transmit files from such sites
- Agree not to harass or intimidate others, by transmitting or making accessible offensive, annoying or harassing material
- Agree not to use the DEVICE to operate a business, for illegal activities, or in a manner that would cause harm to the district or the sustainability of this program
- Agree to be fully responsible for replacement or repair of DEVICE due to theft, loss, or damage by either the purchase of a Device Protection Plan through the School, or pay actual costs for the repair and or replacement of the DEVICE
- Agree to notify the School immediately of any damage to the unit regardless of cause
- Agree that STUDENT may be expected to take DEVICE home for remote work

STUDENTS GRADES 5 - 12

Term: This AGREEMENT is for the current and all proceeding schools years for which STUDENT is enrolled in Buchanan Schools. To be released from this AGREEMENT the DEVICE must be returned and GUARDIAN must contact the school requesting termination of AGREEMENT. While this agreement refers to a specific student and a specific assigned device, the school reserves the right to replace DEVICE with a similar model and update/revise the serial number herein, should such action be deemed necessary.
