Letter of Agreement Between the
BUCHANAN COMMUNITY SCHOOLS TRANSPORTATION ASSOCIATION
and the
Buchanan Community Schools Board of Education

In consideration of their mutual covenants reflected in this Agreement, the Buchanan Community Schools Transportation Association and the Buchanan Community Schools Board of Education (the Board) agree as follows:

1. To add the following language to the Trip Assignment section.
 - A. B7. Trip Assignment
 - A. Notice and Assignment:
 8. **Assignment of Split Athletic Trips:** If an originally assigned trip includes two or more athletic teams and is subsequently split into two separate trips, the driver who was originally awarded the combined trip shall have the right to choose which of the resulting split trips they will take.
 9. **Multiple buses assigned to a trip:**
 - A. **Bus Cancellation:** If a bus is cancelled, the last driver who selected the trip will be removed from the assignment.
 - B. **Driver Withdrawal:** If the first driver to select the trip later decides not to take it, the next driver in the original bidding order will be given first choice before going back to normal rotation.
2. This Agreement is not intended to set a precedent and in no way modifies any other provision of the parties' collective bargaining agreement.
3. This Agreement expires on June 30, 2029, with the option to set a new expiration date if both parties are in agreement. The District Administration and/or Board of Education has the right to revoke this LOA if needed.
